INGREDIENTS

Grain products, plant protein products, molasses products, processed grain by-products, calcium carbonate, urea, potassium chloride, salt, pork fat (preserved with BHA), sodium sesquicarbonate, sodium bicarbonate, zinc sulfate, sodium carboxymethylcellulose, roughage products, manganese sulfate, selenium yeast, copper sulfate, zinc proteinate, manganese proteinate, vitamin E supplement, copper proteinate, thiamine mononitrate, mineral oil, cobalt proteinate, vegetable oil, vitamin A supplement, ethylenediamine dihydroiodide, vitamin D-3 supplement, and cobalt carbonate.

ACTIVE DRUG INGREDIENTS: Monensin, 26.25 g/ton.

FEEDING DIRECTIONS

Each pound of United Equity Calf Finisher MON26.25 contains 13.125 milligrams of Monensin. Hand feed at the rate of 1.07 to 7.6 pounds per 100 pounds of bodyweight to provide 0.14 to 1.0 milligram of Monensin per pound of bodyweight with a maximum of 200 milligrams Monensin per head per day depending on the severity of challenge. Provide a source of clean, fresh drinking water at all times.

- Our Calf Finisher introduces a supplemental pellet:
 - Contains **NPN** for added cost value and added rumen production.
 - Contains **Yea-Sacc®**, which reduces fluctuation in pH and keeps rumen microbes steadily active, which speeds feed digestion and rumen turnover, allowing greater intake. It also stimulates the growth of fiber-digesting bacteria for improved forage breakdown. This addition lowers feed cost and increases average daily gain.
- Feed United Equity Calf Finisher starting at 500-550 pounds to desired finish weight.

WARNINGS

Do not use in calves to be processed for veal. A withdrawal period has not been established for this product in pre-ruminating calves. **CAUTION:** Do not allow horses or other equines access to formulations containing Monensin. Ingestion of Monensin by equines has been fatal. Do not feed undiluted. Monensin medicated cattle and goat feeds are safe for cattle and goats only. Consumption by unapproved species may result in toxic reactions. Do not exceed the levels of Monensin recommended in the feeding directions, as reduced average daily gains may result. If feed refusals containing Monensin are fed to other groups of cattle, the concentration of Monensin in the refusals and amount of refusals fed should be taken into consideration to prevent Monensin overdosing. Feeding undiluted or mixing errors resulting in high concentrations of Monensin has been fatal to cattle and could be fatal to goats.

This product, which contains added copper, should not be fed to sheep or related species that have a low tolerance to copper. This product has been formulated specifically for beef cattle and is not intended for other species. **Caution:** Follow label directions. Feeding this feed containing added selenium at levels higher than recommended is not permitted.
